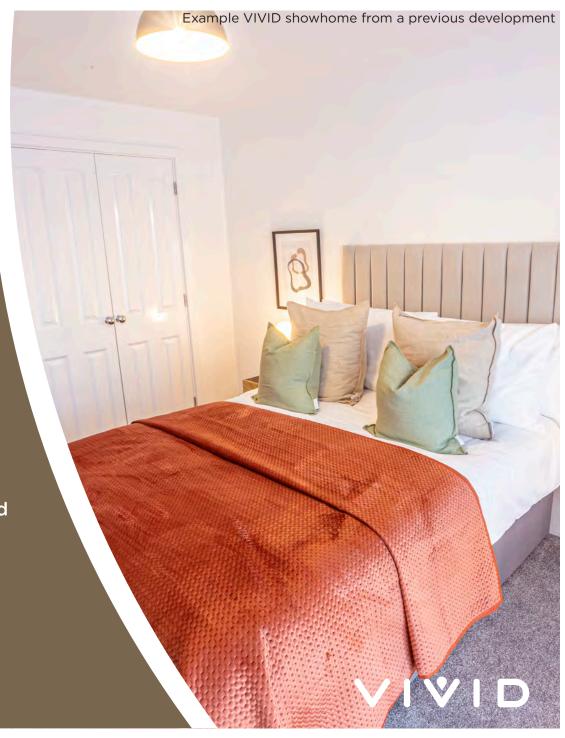




THE LOCATION
