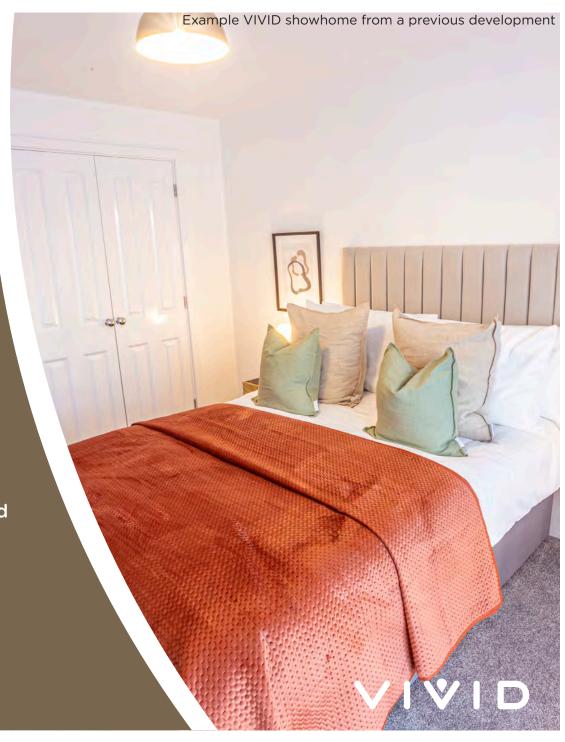

Pagham and Aldwick beaches are both just a 5 minute drive away. Ideal for sunny days and beach walks to blow away the cobwebs.

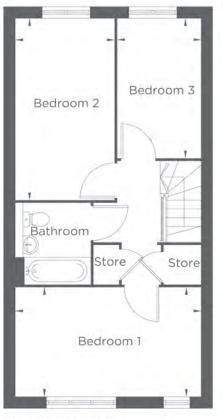

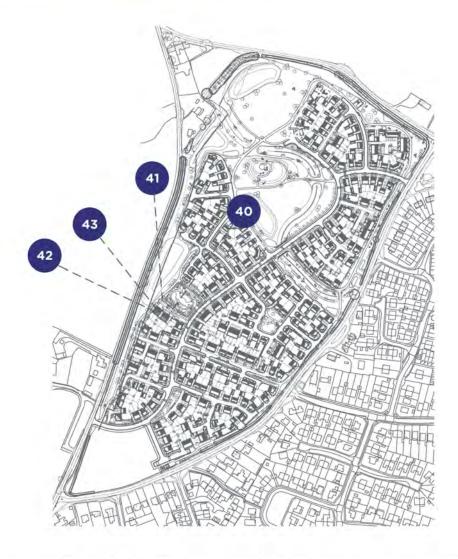


Plot 42, 43 3 BEDROOM HOUSE

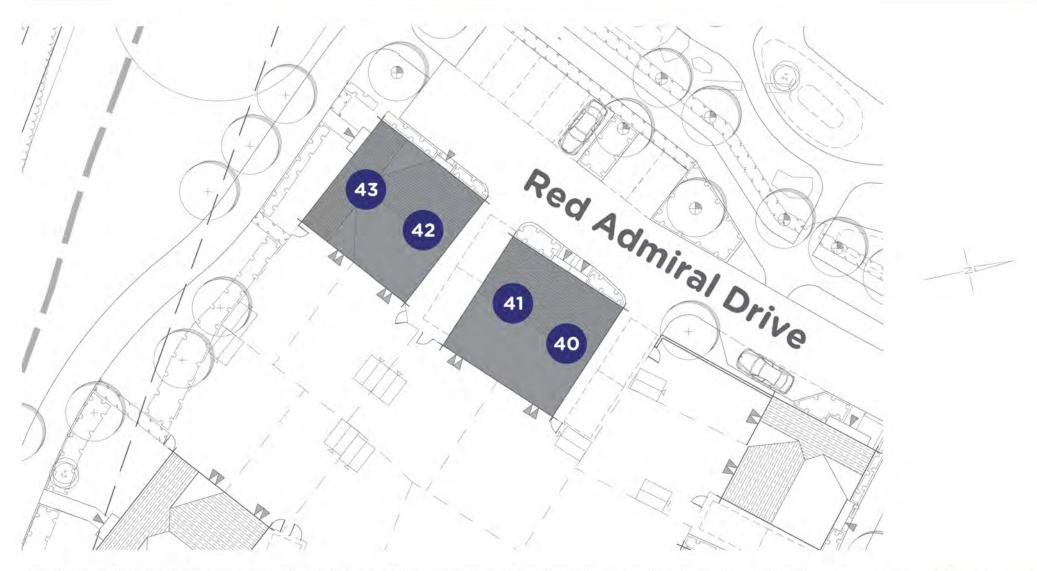

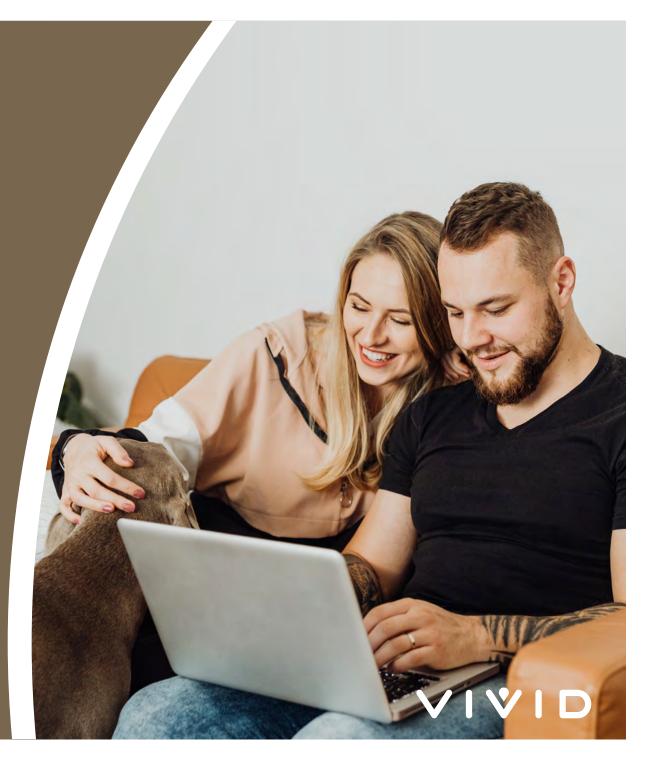

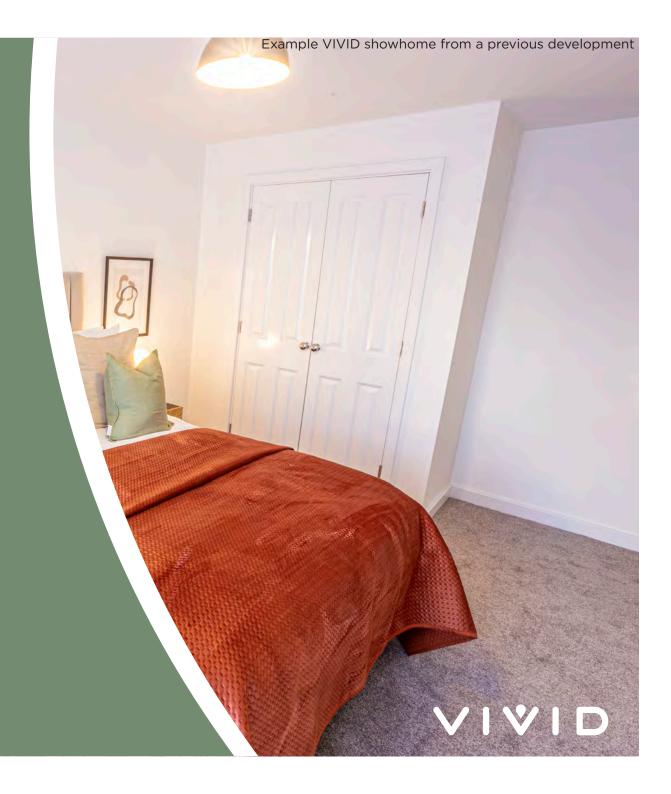

Every 3 months we will have the homes revalued, to make sure they're in line with the current market. This means the price is non-negotiable. It also means the value of the homes could go up or down, so are subject to change.

If purchasing a property off-plan Handover dates are only projected and subject to change. Vivid will inform you of any changes to projected handover dates as and when received by the developer.
