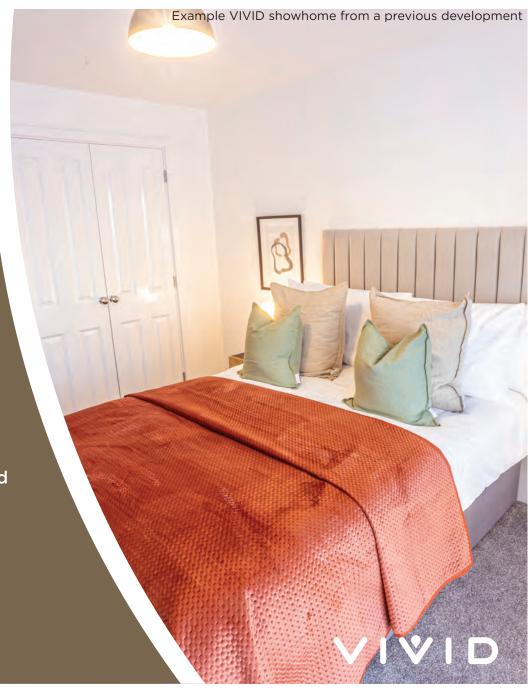

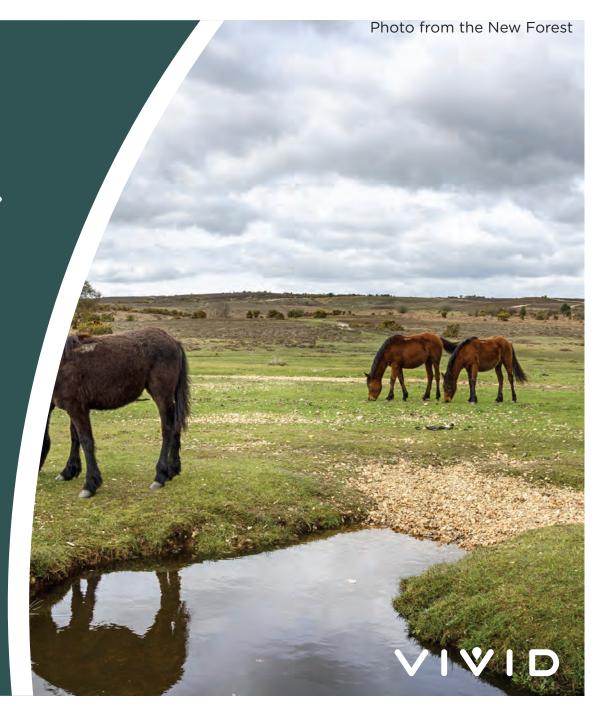


THE DEVELOPMENT

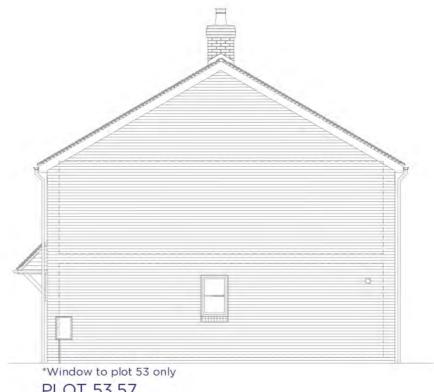
