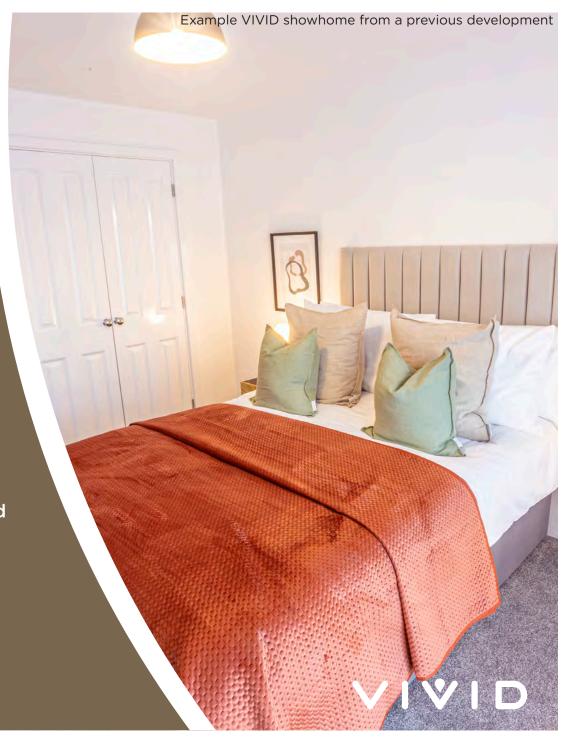

Nowadays the thriving town has craft brewers carrying on the tradition including the Triple fff Brewery whose Alton's Pride tipple can be found in local pubs.

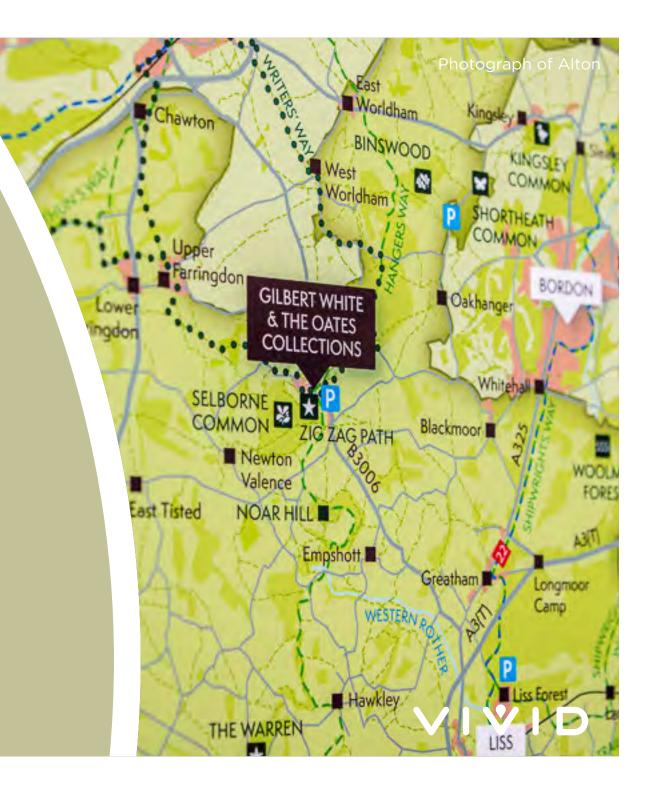


THE LOCATION
